PROGRAMS OVERVIEW



Transforming lives together — the YWCA of San Diego County empowers women, children, and families to break the cycle of domestic violence and homelessness, and achieve self-sufficiency. Our residential programs and comprehensive services include safe housing, counseling, legal assistance, employment support, financial literacy training, and engaging children's programs.

Becky's House®

1 in 4 women and 1 in 7 men will experience domestic violence in their lifetime. The Becky's House program encompasses a 24-hour domestic violence hotline, an emergency shelter and four transitional housing communities, coupled with supportive services. With a total of 190 beds for victims of domestic violence, Becky's House is the largest provider in San Diego County.

24-Hour Domestic Violence Hotline: 619.234.3164

Staffed by trained professional domestic violence advocates who are certified by the California Office of Emergency Services, the hotline provides crisis resources, referrals, and information 24 hours a day, 7 days a week.

The Vi McKinney Becky's House Shelter

The 30-day emergency shelter offers a safe, confidential, temporary home for women, men and children in need of immediate protection where they focus on safety planning, legal services, counseling, and housing as they begin to recover from trauma.

Transitional Housing

The 12-18 month program offers safe, confidential housing and supportive services for women, men and children where they focus on returning to school, career development, financial planning, counseling, and obtaining permanent housing.

Passages

The 18-month program offers 62 beds of transitional housing, case management, financial education, counseling and employment assistance for single homeless women to overcome trauma and transition into independent living. Many of these women are victims of domestic violence or other trauma, and have little or no income. The program focuses on developing individual plans that address specific barriers and lead to employment and permanent housing.

Cortez Hill Family Center

The 120-day program offers 150 beds of transitional housing, case management, counseling, and employment assistance, for homeless families to overcome trauma and transition into independent living. The Cortez Hill Family Center focuses on stabilizing the family unit and developing individual plans to regain employment and obtain permanent housing.

Community Services

In addition to services for residents, the YWCA also provides legal and counseling services to the greater San Diego community.

Legal

The YWCA provides free mobile legal clinics and services to survivors of domestic violence, including family law matters such as restraining orders, divorce, child custody, paternity, and child and spousal support.

Counseling

Skilled therapists offer counseling to individuals, families, couples and children on a sliding fee scale. Areas of focus include relationships, trauma, grief, loss, addictions, anxiety, and depression.
